

Centralina Economic Development District (EDD) released its five-year update for the U.S. EDA Comprehensive Economic Development Strategy (CEDS) on December 1, 2022. Centralina EDD engaged a variety of stakeholders across the region and conducted a robust data analysis of current economic conditions so that the plan would reflect local realities and shared regional aspirations. The CEDS Steering Committee synthesized the data and feedback to develop a compelling "**Prosperity for All**" vision for the region's future:

The greater Charlotte region collaborates to inclusively support businesses, innovators and individuals in reaching a prosperous and globally connected future.

Three themes (people, place, economy) emerged from this vision that informed the CEDS framework and goals:



Throughout the year, the Centralina EDD team has been working to advance the CEDS in 2023, which includes a total of 15 Recommendations and 58 Action Items. Among these, 26 action items are designated as requiring **Urgent** attention and shall be initiated by June 2024.

As of November 2023, the Centralina EDD and regional partners have already moved on 16 of these 26 urgent items with an overall total of 34 action items in motion. The remaining 24 action items that have not been started are categorized as either **Critical** or **Moderate** priorities and have an anticipated initiation timeline set for June 2025 (marked critical) or June 2027 (marked moderate). Encouragingly, 12 of these critical and moderate items have already been set into motion.



# **Advancing Action Items**

Activities that are moving toward achievement.
